

## **PRIVACY TERMS**

We respect the privacy of visitors to the website and ensure that the personal information you provide is treated confidentially. Processing of the personal data in our company takes place in a manner that is in accordance with the legal requirements as foreseen in EU regulations from 25 May 2018.

### **Purposes of data processing**

Your personal data will be processed by us for entering into and executing agreements and bookings, possibly concerning the handling of complaints and legal services and for managing the resulting relationships, including carrying out activities aimed at increasing the customer base.

### **Completing forms via the website**

If you fill in a contact or registration form or on the website, or send us an e-mail, the data you send us will be kept for as long as the nature of the form or the content of your e-mail is required for the full answering and handling. You can indicate whether you wish to be kept informed.

### **Click behavior and visit data**

General visitor data is kept on the website. In this context, in particular the IP address of your computer, the possible user name, the time of retrieval and data that the browser of a visitor sends, can be registered and used for statistical analyzes of visiting and clicking behavior on the website. We also use this data to optimize the operation of the website. We try to anonymize these data as much as possible. This information is not provided to third parties.

### **Facebook and Twitter (social media)**

The website contains buttons for promoting or sharing pages on social networks such as Facebook and Twitter. These buttons are realized by code that is supplied by Facebook and Twitter itself. This code places, among other things, a cookie. You can read the privacy statement of Facebook and Twitter (which can change regularly) to see what they do with your personal data that they process with this code. This also applies to other social media channels.

### **Use of cookies**

We use cookies when offering electronic services. A cookie is a simple small file that is sent along with pages from this website and stored by your browser on the hard disk of your computer. This allows us to combine various requests for pages from the website and analyze the behavior of users. You can refuse the use of these cookies, although this may limit the functionality and ease of use of the website.

### **Right of inspection, improvement, deletion, limitation, objection and portability**

The customer has the right to inspect his / her personal data at all times and can correct them if they are incorrect or incomplete, have them removed, limit their processing and object to the processing of personal data concerning them, including profiling on them. based on these provisions. Moreover, the customer has the right to obtain a copy (in a structured, current and machine-readable form) of his personal data and to have the personal data forwarded to another company.

### **Direct marketing**

The customer has the right to object free of charge to any processing of personal data for direct marketing.
